**ASSUMPTION OF RISK, INDEMNIFICATION, RELEASE,
WAIVER, AND AUTHORIZATION AGREEMENT (“Agreement”)**

We promise that we have read and understood this Agreement, and that we understand that signing this paper adds to our legal duties and reduces our legal rights and that we are being allowed to enter the Contest in reliance upon our promises, agreements, and representations made in this paper including, without limitation, the representation that we understand the meaning of this Agreement.
